**Condition:**

- 1 The income and property/debts of the society shall be applied solemnly towards the promotion of the objects of the society as set forth in the memorandum of association and no portion thereof shall be paid or transferred directly or indirectly to the members of the society.
- 2 No members of the society shall be appointed to any salaried office of the society or any office of, the society paid by fees. that no remuneration shall be given by the society to any member except repayment of out of Pocket expenses and interested on money lent or rent for premises to the society.
- ③ The Society by its constitution is required to apply its profit if any or other income in promoting its objects.
- 4 If upon the winding up or dissolution of the society there remains after satisfaction of all its debts and liabilities any property what soever the same shall no be paid or distributed among the members of the society but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined by the members of the society at or before the time of dissolution.

# RULES AND REGULATIONS OF THE SOCIETY

Name of Society M.P. (Mahavir Parsad ) Education Society

Registered Office V.P.O. Arnianwali Distt. Sirsa

Area of Operation All Haryana

## 1. INTRODUCTION

The society will open school/college/Sheiter house/ distribute scholarship to the poor and brilliant students /quez Contest organise the functions as blood donation camp /Medical camps in slum areas to arrange the marriages of poor girls and organise religious function time to time, and will look into the moveable and immoveable property of the society.

## 2 Terms and Conditions for Admissioin of Members:

Any person who has attained age of 18 years and is otherwise considered suitable can become a member of the society on payment of prescribed subscription Rs. 1000/- per year, after his/her name has been approved by the Governing Body..

3 A fine of Rs. 100/- will be charged annually from the members on non payment of subscription fee.

4 Fine and forefiture to be imposed on any member for non payment of annual dues.

## 5 Categories: There will be two categories

i) Life Members:

A person can become a life member on payment of Rs. 1000/- as life membership fees.

ii) Ordinary members:-

Any person who was attained the age of 18 years is otherwise considered suitable can become a member of the sdciety on payment of prescribed subscription after the name has been approved by the Governing Body.

## 6 Resignation and expulation of members

a) If he/she dies or resigns.

b) If he/she does not pay minimum subscription within one month from the date of enrolment.

c) If he/she does not attend three excecutive meetings.

d) If he work against the rules and regulations of the society, the person concerned can be removed from the membership of the society.

## 7 Formation of General Body

i) The General body will consists of not less than 10 members.

ii) All the Life members and ordinary members will from the General Body of the society.

## 8 Power and functions of the General body:-

a) Shall make rules and necessary changes in the constitution as and when required.

b) Shall creat funds for the society etc

c) Shall collect funds through Govt. grants, public donations , interest, subscription and fees etc.

d) The General body will be responsible for actual management of all the affairs of the society subject to the formal approval of the General body.

9) a) **Quorum:**

- i) General body will meet at least once in a year but in special case this may be called when ever necessary with the permission of the President.
- ii) A fortnight notice will be essential for general body meeting.  
Under special circumstances meeting may be called by the Secretary with the approval of President in weeks notice.
- iii) The quorum will be of 3/5 members of the society

10 **Bank Account & Funds :**

The Bank Account of the society shall be operated by the Joint signatures of any two of Treasurer, President and Secretary. The payment shall be made by Account Payee Cheque & by cash only. Society may seek loans/grants from Banks/ Nationalised Banks Govt. and financial institution.

11) **Formation of Governing Body:**

- i) The governing body shall consist of not less than and not more than 7 members.
- ii) The superintendence, control and directions of the affairs of the society its income and property (Movable and immovable) shall be entrusted to the Governing body.
- iii) The term of the Governing body shall be three years. A member whose term expires shall be eligible for re-election.

12 **Strength of the Governing Body**

There will be 7 members including the Secretary.

13 **Mode of Election of Governing Body**

The members of the Governing body shall be elected unanimously. Show of the hands with majority in the meetings of General body or by ballot in case of dispute. Election will be conducted after every three years.

14 **Powers and functions of the Governing Body:-**

- a) Shall make rules and necessary change in the constitution as and when required.
- b) Shall creat funds for the society, institutions etc.
- c) Shall manage scholarship and other grants for promotion of the education and other charitable work.
- d) Shall collect funds through Govt. grants, public donations, interest subscription and fee etc.

15 **Meeting /Quorum, notice of the Governing Body.**


- i) The Governing body shall ordinarily meet once in every three months.
- ii) The notice of the meeting will be served at least 7 days ahead, in special circumstances the Secretary with the consent of the President will have power to call the meeting by giving 3 days notice
- iii) The quorum of the meeting will be of minimun 3/5 members of the Governing Body.


**Patrons**

There will be two Patrons and they will be Honourable members and will give their valuable suggessions time to time to the management as well as general body meeting. Patrons observe the functions of society.



- c) Secretary sign the documents to transact business on behalf of the society.
- d) Secretary will maintain the records and property of the society.
- e) Secretary will make all arrangement for holding meetings.
- d) Secretary will deal with the Govt. and other educational institutions.
- g) Secretary will check the bills/Vouchers.
- h) Secretary will receive grant from the Govt. donations funds and other charitable institutions.

**Joint Secretary**

In the absence of Secretary he will look after the work of Secretary and do any other work as authorised by the Governing body/President.

**The Treasurer**

- 1) The treasurer will maintain the account books and get them checked by the Secretary or President
- 2) Treasurer will get the accounts audited annually.
- 3) Treasurer will keep the Gen. secretary in touch with the financial position of the society.
- 4) Treasurer will present financial report and budget of the proceedings year in Annual General body meetings.
- 5) Treasurer will prepare budget for the current year in consultation with the Secretary of the institute.
- 6) Records like proceedings register, stock register, cash book, Ledger etc. shall be maintained. Financial year of the society shall be from 1st April to 31st March every year.  
The managing committee shall appoint a qualified auditor for checking of accounts, balance sheet utilisation certificate or any other financial statement as may be needed.

**Dissolution**

The society shall be dissolved as per societies Registration Act 1860 with the consent of 2/3 member. All the immovable properties of the society shall be handed over to another society persuing similar activities as dicided by the governing body after payment of all the liabilities.
