Any kind of alteration/extension/change in occupancy is prohibited.
3. Occupants/owners should have trained staff to operate the operation of fire safety system provided therein.  
  
Ensure that residents/owners are made aware of the use of available fire extinguishers.
4. Fire Officer can check the arrangements of fire safety at any time, this certificate will be withdrawn without any notice if any deficiency is found.  
  
The fire brigade officer can check all these arrangements at any time, if any deficiency is found, then this certificate will be considered canceled without any notice.
5. Occupants/owners should apply for renewal of fire safety certificate one month prior to expiry of this certificate.

The owner will be required to renew the issued fire safety certificate one month before its expiry date.
